ComplyALIGN Pain Point #1:

No Centralized Location for Policies and Procedures

"We've used outdated policies because current versions are difficult to find or it is difficult to know where to even look for policies."

This results in major business practices risks, potential lawsuits, unhappy customers or some real major compliance issues.







How Does ComplyALIGN Solve Pain Point #1?

- ✓ It provides a **centralized platform** that can store all policies and procedures.

ComplyALIGN Pain Point #2:

Manual Management of P&Ps and Version Control

"Our P&Ps are mismanaged, not reviewed on time or proper approvals are not correctly documented, our policies are still in binders, and everything is manual."

This complaint results in a poor system for tracking approval workflow and revision history making it close to impossible to produce evidence of correct policy maintenance or compliance in the case of a lawsuit, audit or legal review.







How Does ComplyALIGN Solve Pain Point #2?

- ✓ The system will pro-actively notify owners and reviewers about upcoming review requirements.
- ✓ Approvals are handled electronically and automatically stored for each document.
- ✓ Sequential approvals can be defined to ensure a proper approval process is in place.
- ✓ Approver name, date, time or approval are easily accessible for each document.

- ✓ When a policy is revised the previous version (and also all draft copies) are automatically preserved and accessible to authorized staff.
- ✓ Detailed audit logs are created anytime a change to a document is made or a review or approval takes place.
- ✓ Policy owners can run reports showing exact versions of policies that were in effect on a specific date making it extremely easy to complete legal reviews.





KingsBridgeBCP Pain Point #2:

Manual Management of Plans and Approvals

- ✓ No idea when a document was last modified.
- ✓ Not sure if the plan, or associated documents were ever approved, by whom, and when.
- ✓ Not sure how current the overall plan is.







How Does SHIELD Solve Pain Point #2?

- ✓ Last Modified dates on all content along with who made the modification.
- ✓ Last Modified table to look at when all content was last updated.
- ✓ Built in task management system allows you to assign a plan or document for review and tells you when the task is complete. Mark tasks as urgent and send email notifications when a task is assigned.
- ✓ Tasks can be linked directly to the content that needs to be reviewed so there
 is no question as to what is being asked of the reviewer.





ComplyALIGN Pain Point #3:

Not Being Audit Ready

"If we were to get audited today, we would likely fail the audit because our internal P&P review and attestation processes are not in place, approvals are not correctly documented and policies are difficult to locate."

This can result in not being able to apply for certain programs/discounts/bid for projects because policies and procedures are in such a chaotic state that you will likely fail.

ComplyALIGN Pain Point #4:

No Reporting Tools

"We don't know how many policies and procedures we deal with, who manages them or how they even get reviewed. If our policy staff left the organization, we wouldn't know where to start.

This issue results in an extremely heavy manual workload for a new hire or additional staff set to replace the previous policy administrator/owner.







How Does ComplyALIGN Solve Pain Point #4?

- ✓ The system reinforces a "set it and forget it" mindset. Once document review workflow is identified, appropriate staff automatically gets notified when their tasks are DUE.
- ✓ The system reinforces accountability and transparency. System superusers can easily run report to see policies pending action and overdue documents along with assigned staff.

- ✓ At any point of time system super users can run responsibility assignment reports to see what tasks different staff has.
- ✓ If staff leaves, documents can be reassigned across the board to the new person and tasks notification will automatically follow new document assignments.
- ✓ New staff would automatically be notified about his or her tasks.





How Does ComplyALIGN Solve Pain Point #4? Cont'd

- ✓ Volume of documents, number of current draft, published documents and archives are automatically maintained in the system and accessible to authorized users.
- ✓ Dashboards and charts help visualize status of documents across the entire system.
- ✓ Read acknowledgement/attestation can be configured to ensure staff is notified about new document versions and changing policies.
- ✓ Policy quizzes can be configured to ensure staff understanding of policies and procedures.


